A. Qualification of Bidders

Sole proprietor, partnership and or corporations are qualified to participate in the bidding, subject to the submission of qualification documents as follow;

- SEC Registration for corporation
- DTI Registration Certificate and valid Business Permit for sole proprietorship
- Certificate of Authorization must be submitted by the representative issued by the President/ General Manager/ Governing Board/ Owner of the firm/company, as may be applicable, authorizing him/her to speak for, sign and submit bids in behalf of the Owner or officer of the firm/company.

B. Inspection of Unserviceable Properties

Unserviceable properties for sale are available for viewing and inspection during office hours with the assistance of DA personnel on **August 8-9, 2024 between 10:00-11:30 AM and 1:00-3:00 PM** at DA-Caraga Regional Office and ILD-Taguibo, Butuan City.

Prospective bidders are advised to check the unserviceable properties prior to the date of the Opening of Bids and shall accept the physical condition and actual state at the time of the Public Auction.

C. Bid Form

The bid form and instruction to bidders can be acquired at Gen. Services Section. It must be secured prior to the Opening of Bids.

E. Schedule of Public Auction

The public auction shall be conducted on an "As Is, Where Is" basis on August 12, 2024 at 9:00 A.M. at DA Regional Office, Capitol Site, Butuan City.

F. Submission of Bids

- a. The bid must be submitted using the prescribed Bid Proposal Form to the Gen. Services Section (GSS), in a duly signed and sealed envelope. It shall be properly labelled with ITB Number, bidder's name, address and contact number/s. A sealed box shall be made available at GSS where bidders should place their bids. The bid proposal shall be signed by the bidder or his duly authorized representative. Unsigned bids shall be disqualified and shall not be accepted.
- b. The bid proposal shall be per lot.
- c. Bids submitted below the floor price, unsigned bids and bids without the corresponding Bid Bond shall be disqualified and shall not be accepted.



d. Deadline for submission of bids is on **August 12, 2024 at 8:59 P.M.** at DA Regional Office, Capitol Site, Butuan City. Bids submitted beyond said deadline shall not be accepted.

G. Opening of Bids

- a. Opening of Bids will immediately follow after the deadline of submission of bids in the presence of BAC on Disposal, Disposal Committee, bidders who choose to attend and witness by COA or its representative.
- b. A bid submitted cannot be changed or withdrawn after the deadline of submission of bid.
- c. An Abstract of Bids shall be prepared by the BAC on Disposal.
- d. Should there be a tie in the highest offered price, the concern bidders shall "draw-lots or toss coin" to break the tie.
- e. The Department of Agriculture reserves the right to reject any or all bids, waives any defects contained therein without any reason and will accept the offer most advantageous to the government. Further, the Agency assumes no obligation whatsoever to compensate or indemnify the bidder for any expense or loss they may incur in participating in this undertaking nor does guarantees that an Award will be made.

H. Rid Bond

The bid proposal shall be accompanied by the Bid Bond in the form of CASH or Cashier's/Manager's Check Payable to the Department of Agriculture-Caraga equivalent to 10% of the total bid per lot. A bid without Bid Bond or below the required amount shall be disqualified. The bid bond must be submitted and presented by the bidder during the actual opening of the respective/individual bid.

Such bond shall be refunded to losing bidders after the declaration of the winning bidder while the winning bidder's bid bond shall automatically be considered as partial payment.

I. Notice of Award

Award shall be made to the highest and responsive bidder per lot. All items should have corresponding bid price quotation. The highest and responsive bidder shall settle the bidded amount in full within five (5) calendar days upon receipt of Notice of Award. In case of failure of payment of the bid price within the required period, the award shall be cancelled and the bid bond shall be forfeited then be awarded to the next highest bidder.



J. Notice of Proceed

The Notice of Proceed (NTP) shall only be issued once the highest and responsive bidder paid the full amount of the bid price.

The Official Receipt (OR) showing the full payment of the bid price shall be presented to the Chief Administrative Officer which shall serve as the basis for the preparation of Release Order within five (5) working days upon receipt of OR.

K. Pull-Out/Taking-out of Awarded Items

The winning bidder is required to take possession of the unserviceable assets within five (5) working days after receipt of the Release Order, otherwise he/she shall be charged with daily storage fee in the amount equivalent to one percent (1%) of the floor price of the subject equipment/properties or **Five Hundred Pesos (₱ 500.00)** whichever is higher.

The highest winning bidder shall likewise be responsible for the cost of the transfer of the various unserviceable equipment.
