WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last December 5, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Various Drugs & Biologics under the Livestock Program grouped into seven (7) lots as follows:

Lot 1 - Injectable/ Soluble Supplements	P 2,783,186.00
Lot 2 - Dewormer/ Endectocide	630,510.00
Lot 3 - Vaccines (Biologics)	356,400.00
Lot 4 - Antibiotics	694,347.00
Lot 5 - Anti Inflammatory	90,000.00
Lot 6 - Anti Protozoans/ Trypanocide	765,989.00
Lot 7 - Anesthetics/ Tranquilizers/Pre-Anesthetics	175,360.00

WHEREAS, an opening of bids was conducted last December 28, 2020 at the DA Conference Room as scheduled and the BAC had declared P & J Agricultural Trading, Inc.'s bid as "passed" during the preliminary examination of bids;

WHEREAS, said bid was subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC last February 2, 2021;


WHEREAS, upon deliberation, the BAC declared the bid submitted by P & J Agricultural Trading, Inc. as a Single Calculated Bid for Lots 1 and 2 and Lots 5-7 and qualified to undergo post qualification;

WHEREAS, P & J Agricultural Trading, Inc.'s bid for Lot 3 - Vaccines (Biologics) failed due non-conformity with the specification on the expiry date of the vaccines.


