WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last December 5, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Dairy Goat and Free-Range Chicken under the 4Ks Program GAA 2021 grouped into Two (2) lots as follows:

<b>Lot 1 – Dairy Goat (4 heads Buck &amp; 40 heads Doe)</b>	<b>P</b>	<b>1,628,000.00</b>
<b>Lot 2 – Free Range Chicken</b>		<b>576,000.00</b>
<b>(800 heads Ready to lay Pullets &amp; 160 Heads Cockerel)</b>		

WHEREAS, an opening of bids was conducted last December 28, 2020 at the DA Conference Room as scheduled and the BAC had declared BMA Livestock Dealer, Tommys Hogs and Cattle and Julimon's Enterprises' bid as "passed" during the preliminary examination of bids;

WHEREAS, said bid was subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC last February 2, 2021;

WHEREAS, upon deliberation, the BAC declared the bids submitted by Tommys Hogs and Cattles for Lot 1 – Dairy Goat and Julimon's Enterprises for Lot 2– Free-Range Chicken, as Lowest Calculated Bid and qualified to undergo post qualification;


