**BAC RESOLUTION RECOMMENDING FOR THE AWARD FOR PROCUREMENT OF VARIOUS VEGETABLE SEEDS (A10)**

Resolution No. 027-2021  
Series of 2021

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last December 5, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Various Vegetable Seeds under the HVCDP Program grouped into two (2) lots as follows:

**Lot 1- Lowland Vegetable Seeds - P 5,198,350.00**  
**Lot 2- Upland Vegetable Seeds - 291,700.00**

WHEREAS, an opening of bids was conducted last December 28, 2020 at the DA Conference Room as scheduled and the BAC had declared bids of Seedworks Philippines, EastWest Seed Company and Ramgo International Corporation as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the result of detailed bid evaluation, the BAC declared the bid submitted by EastWest Seed Company as the Lowest Calculated Bid for Lot1 and the lone bid for Lot2;

WHEREAS, the BAC together with the TWG conducted the post qualification to determine the authenticity of the submitted documents last March 3, 2021 and its capability to supply the required seeds;


WHEREAS, the BAC also considered its performance of the previous contracts with this Office, in addition to the verification and authentication of submitted documents;


WHEREAS, upon final deliberation conducted by the BAC members, it was found out that EastWest Seed Company had passed the post qualification requirements and was declared the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the procurement of Various Vegetable Seed: Lot 1- Lowland Vegetable seeds and Lot 2- Upland Vegetable seeds to EastWest Seed Company as its bid was considered as the Lowest/Single Calculated and Responsive Bid.




