**BAC RESOLUTION RECOMMENDING FOR THE AWARD FOR THE PROCUREMENT OF LIVESTOCK AND POULTRY (A8)**

Resolution No. 071-2021  
Series of 2021

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last December 5, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Livestock and Poultry under the Livestock Program grouped into Four (4) lots as follows:

Lot 1 - Large Ruminant	P	4,000,000.00
Lot 2 - Small Ruminant		1,919,500.00
Lot 3 - Poultry		720,000.00
Lot 4 - Gilt		1,400,000.00

WHEREAS, an opening of bids was conducted last December 28, 2020 at the DA Conference Room as scheduled and the BAC had declared Welissa Farms Corporation, BMA Livestock Dealer, Tommys Hogs and Cattle and Julimon's Enterprises' bid as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the result of detailed bid evaluation, the BAC declared the bid submitted by BMA Livestock Dealer for Lot 1 Large Ruminant; Tommys Hogs and Cattles for Lot 2 - Small Ruminant; Julimon's Enterprises for Lot 3 - Poultry and Welissa Farms Corporation for Lot 4 - Gilt as the Lowest Calculated Bid and to undergo post qualification;


WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents last February 5, 2021 and considered its performance of the previous contracts with this Office, in addition to the verification and authentication of submitted documents;


WHEREAS, upon final deliberation conducted by the BAC members, it was found out that BMA Livestock Dealer for Lot 1 Large Ruminant; Tommys Hogs and Cattles for Lot 2 - Small Ruminant; Julimon's Enterprises for Lot 3 - Poultry and Welissa Farms Corporation for Lot 4 - Gilt, passed the post qualification requirements and were considered as Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the procurement of Livestock & Poultry to BMA Livestock Dealer for Lot 1-40 Head Cattle(Helifer) and 40 heads Carafeifer; Lot 2- 55 heads Dairy Goat to Tommys Hogs and Cattles; Lot 3-1,000 heads Free Range Chicken and 200 Heads Cockerel to Julimon's Enterprises; and Lot 4 - 40 Heads Gilt Swine to Welissa Farms Corporation as their bid was considered as Lowest Calculated and Responsive Bid.


