

BAC RESOLUTION ON THE DETAILED BID EVALUATION FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF SEVEN (7) UNITS WAREHOUSE (B26)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Labor and Materials for the Construction of Seven (7) units Warehouse under the Rice Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of P14,000,000.00 and grouped into three (3) lots as follows:

Lot 1-3 units warehouse located at Mat-i, Surigao City, Honrado , San Francisco, SDN and Villaflor, Gigaquit, SDN

P6,000,000.00

Lot 2- 2 units warehouse located at San Francisco, Mainit, SDN and Don Julio Ouano, Alegria, SDN

P4,000,000.00

Lot 3-2 units warehouse located at Cabunga-an, Cagdianao, PDI and Cabalawan, Libjo, PDI

P4,000,000.00

WHEREAS, a pre-bid conference was held last February 19, 2021 at the DA Conference Hall, Department of Agriculture- Caraga Region, Capitol Site, Butuan City as scheduled;

WHEREAS, an opening of bids was conducted on March 4, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and there were six (6) bidders who bought and submitted its bid, namely BN Builders and Construction Supplies, LGTD Construction and Development, Amalgo Construction, ASJ Builders, GC Construction and Two J. E. Construction and Supply;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of each bid and all bidders were rated as "passed";

WHEREAS, the financial component of the above six (6) bids were opened and read as indicated on the abstract of bids which are subject to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Amalgo Construction for Lots 1, 2 and 3 is the Lowest Calculated Bid (LCB) subject for post qualification;
