**BAC RESOLUTION ON THE DETAILED BID EVALUATION FOR THE
PROCUREMENT OF VARIOUS CHEMICALS (B27)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Chemicals under the Special Area of Agricultural Development (SAAD) Project with a total Approved Budget for the Contract (ABC) of P1,118,230.00 and grouped into three (3) lots as follows:

Lot 1- 295 liters Insecticides	P383,500.00
Lot 2- 285 kilos Fungicides	P278,730.00
Lot 3- 285 gallons Herbicides	P456,000.00

WHEREAS, a pre-bid conference was held last February 19, 2021 at the DA Conference Hall, Department of Agriculture- Caraga Region, Capitol Site, Butuan City as scheduled;

WHEREAS, an opening of bids was conducted on March 4, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and there were three (3) bidders who bought and submitted its bid, namely RMB Agro Chemicals Trading Corp., J-777 Agri Marketing Corp. and Mars Ventures and Commodities Inc.;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of each bid and all bidders were rated as "passed";

WHEREAS, the financial component of the above three (3) bids were opened and read as indicated on the abstract of bids which are subject to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by RMB Agro Chemicals Trading Corp. for Lots 1, 2 and 3 is the Lowest Calculated Bid (LCB) and subject for post qualification;


