**BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROCUREMENT OF 11,805 BAGS ORGANIC FERTILIZER (B32)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 11,805 bags Organic Fertilizer under Corn Program-GAA 2021 with an ABC of P6,728,650.00:

WHEREAS, an opening of bids was conducted last March 4, 2021 at the DA Conference Room as scheduled and the BAC had declared the bids of Phoenix Agriventures, Roy Agribest, Inc., RMB Agro Chemicals Trading Corp, and Heaven's Bounty Farm as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the result of detailed bid evaluation, the BAC declared the bid submitted by Roy Agribest, Inc. as the Lowest Calculated Bid and to undergo post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and its performance of their previous contracts;


WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Roy Agribest, Inc.'s bid had passed the post qualification requirements and was declared the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 11,805 bags Organic Fertilizer to Roy Agribest, Inc., as its bid was considered the Lowest Calculated and Responsive Bid.
