BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 7 UNITS WAREHOUSE (B26)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of labor and materials for the construction of 7 units warehouse under Rice Program-GAA 2021 grouped into three (3) lots with corresponding ABC:

Lot 1 - 3 units Warehouse (Mat-I, Surigao City, Honrado, San Francisco, SDN, Villafor, Gicaguit, SDN)	P	6,000,000.00
Lot 2 - 2 units Warehouse (San Francisco, Mainit, SDN, Don Julio Ouano, Alegria, SDN)	P	4,000,000.00
Lot 3 - 2units Warehouse (Cabunga-an, Cagdianao, PDI & Cabalawan, Libjo, PDI) P	P	4,000,000.00

WHEREAS, an opening of bids was conducted last March 4, 2021 at the DA Conference Room as scheduled and the BAC had declared the bids of BN Builders & Construction Supply, LGTD Construction & Devt, AMALGO Construction, ASJ Builders, GC Construction, and Two JE Construction & Supply as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the result of detailed bid evaluation, the BAC declared the bid submitted by AMALGO Construction, for Lots 1, 2 & 3 as the Lowest Calculated Bid and to undergo post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and its performance of their previous contracts;


WHEREAS, upon final deliberation conducted by the BAC members, it was found out that AMALGO Construction's bid for Lots 1, 2 & 3 had passed the post qualification requirements and was declared the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply of labor and materials for the construction 7 units warehouse at the above-cited locations to AMALGO Construction, as its bid was considered the Lowest Calculated and Responsive Bid.


