BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 8 UNITS CHICKEN HOUSE WITH FENCE (B20)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of labor and materials for the construction of 8 units Chicken House with Fence under 4Ks Program-GAA 2021 grouped into two (2) lots with corresponding ABC:

Lot 1 - 4 units Chicken House located at Bunawan, ADS	P 1,305,000.00
Lot 2 - 4 units Chicken House located at Rosario, ADS	P 1,305,000.00

WHEREAS, an opening of bids was conducted last March 4, 2021 at the DA Conference Room as scheduled and the BAC had declared bids of ETP Builders, JG_DM Construction & Supply and BN Builders & Construction Supply as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the result of detailed bid evaluation, the BAC declared the bid submitted by BN Builders & Construction Supply, for Lots 1 & 2 as the Lowest Calculated Bid and to undergo post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and its performance of their previous contracts;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that BN Builders & Construction Supply's bid for Lots 1 & 2 had passed the post qualification requirements and was declared the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply of labor and materials for the construction 8 units Chicken House with Fence at the above-cited locations to BN Builders & Construction Supply, as its bid was considered the Lowest Calculated and Responsive Bid.


