WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last December 5, 2020 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Hybrid Corn Seeds under the Corn Program grouped into five (5) lots as follows:

Lot 3 - 68 bags Hybrid Corn Seeds (9kgs/bag)NSIC 2018 GMCn 64	408,000.00
Lot 4 - 68 bags Hybrid Corn Seeds (9kgs/bag)NSIC 2018 GMCn 48	408,000.00
Lot 5 - 68 bags Hybrid Corn Seeds (9kgs/bag)NSIC 2018 GMCn 67	408,000.00
