WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last February 24, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Improvement/Repair of the Research Building (Main RIARC) of Trento RES at Trento, Agusan Del Sur under the Research Division-Bayanihan II Fund with a total Approved Budget for the Contract (ABC) of ₱2,000,000.00;

WHEREAS, a pre-bid conference was held last March 3, 2021 at DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled;

WHEREAS, an opening of bids was conducted on March 16, 2021, 9:15 A. M. at DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and there were two (2) bidders who bought and submitted its bid, namely Jimberns Builders & Construction Supply and Salacop Construction and Supply;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of each bid and two (2) bidders were rated as "passed";

WHEREAS, the financial component of the two (2) bids were opened and read as indicated on the abstract of bids which are subject to a detailed bid evaluation;


WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Jimberns Builders & Construction Supply is the Lowest Calculated Bid (LCB) and subject for post qualification;




