**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF VARIOUS HYBRID RICE SEEDS (C1)**

**Resolution No. 71-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 24, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Hybrid Rice Seeds under the Rice Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of P29,497,520.00 and grouped into seven (7) lots as follows:

Lot 1- 720 bags Hybrid Rice Seeds (M20)	P2,747,520.00
Lot 2- 1,000 bags Hybrid Rice Seeds (Mestizo 13)	P5,000,000.00
Lot 3- 1,000 bags Hybrid Rice Seeds (Mestizo 27)	P5,000,000.00
Lot 4- 1,000 bags Hybrid Rice Seeds (Mestizo 28)	P4,500,000.00
Lot 5- 550 bags Hybrid Rice Seeds (Mestizo 46)	P2,750,000.00
Lot 6- 1,000 bags Hybrid Rice Seeds (Mestizo 80)	P5,000,000.00
Lot 7- 900 bags Hybrid Rice Seeds (Mestizo 81)	P4,500,000.00

WHEREAS, a pre-bid conference was held last March 3, 2021 at DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled;

WHEREAS, an opening of bids was conducted on March 16, 2021, 9:15 A. M. at DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC declared the bids of Jedeco Trading Corp., SL Agritech Corp., Long Ping Tropical Rice Development, and Davao Oriental Seed Producers Cooperative; as "passed" during the preliminary examination of bids

WHEREAS, upon deliberation on the detailed bid evaluation, the BAC declared the bid submitted by Davao Oriental Seed Producers Cooperative for Lot1, Jedeco Trading Corp for Lots 3 & 5, Long Ping Tropical Rice Development for Lot 6 and SL Agritech Corp for Lot 7 as a Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification to all qualified bidders to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Davao Oriental Seed Producers Cooperative, Jedeco Trading Corp, Long Ping Tropical Rice Development and SL Agritech Corp had passed the post qualification requirements and was considered as a Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of Lot 1 to Davao Oriental Seed Producers Cooperative; Lots 3 & 5 to Jedeco Trading Corp; Lot 6 to Long Ping Tropical Rice Development, and Lot 7 to SL Agritech Corp as its bid was considered a Single Calculated and Responsive Bid.

RECOMMENDING FURTHER that a rebid be conducted for Lots 3-4 as there were no bids received;
