**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF
ONE (1) UNIT HAULING TRUCK (C3)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 24, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of One (1) unit Hauling Truck under HVCD Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of P 1,500,000.00;

WHEREAS, a pre-bid conference was held last March 3, 2021 at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled;

WHEREAS, an opening of bids was conducted on March 16, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bid of Global Cars Inc. as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation on the detailed bid evaluation, the BAC declared the bid submitted by Global Cars Inc as the Lowest Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification to Global Cars Inc to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Global Cars Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of One (1) unit Hauling Truck to Global Cars Inc as its bid was considered the Lowest Calculated and Responsive Bid.


