**BAC RESOLUTION RECOMMENDING FOR THE AWARD FOR THE
IMPROVEMENT/REPAIR OF THE RESEARCH BUILDING (MAIN- RIARC) OF TRENTO RESEARCH
AND EXPERIMENT STATION AT TRENTO, AGUSAN DEL SUR (C6)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 24, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Improvement/Repair of the Research Building (Main RIARC) of Trento RES at Trento, Agusan Del Sur under the Research Division-Bayanihan II Fund with a total Approved Budget for the Contract (ABC) of P2,000,000.00;

WHEREAS, an opening of bids was conducted on March 16, 2021, 9:15 A. M. at DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC declared the bids of Jimberns Builders & Construction Supply and Salacop Construction and Supply as passed during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Jimberns Builders & Construction Supply is the Lowest Calculated Bid (LCB) and subject for post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Jimberns Builders & Construction Supply had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;




