**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF VARIOUS AGRI INPUTS FOR TECHNOLOGY DEMONSTRATION (D8)**

Resolution No. 169-2021

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Agri Inputs for Technology Demonstration under HVCD Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of P2,358,000.00 and grouped into two (2) lots as follows:

Lot 1- Various Inputs for Techno Demo on Cacao Establishment, Coffee Establishment and Coffee Rejuvenation	P2,250,000.00
Lot 2- Various Inputs for Techno Demo on Banana Production	P 108,000.00

WHEREAS, an opening of bids was conducted on April 19, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the lone bid of Ramgo International Corporation for Lot 1 as "passed" during the preliminary examination of bids;

WHEREAS, said bid was subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on April 26, 2021 and declared the bid of Ramgo International Corporation for Lot 1 as a Single Calculated Bid (SCB);

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Ramgo International Corporation had passed the post qualification requirements and considered as a Single Calculated and Responsive Bid for Lot 1;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of Various Agri Inputs for Technology Demonstration under Lot 1 to Ramgo International Corporation as its bid was considered a Single Calculated and Responsive Bid;

FURTHER RECOMMENDING, that Lot 2 be declared as failure as there were no bids received and to be procured using the Small Value Procurement Method;

RESOLVED, this 6th day of May 2021 at Butuan City, Philippines.
