**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF VARIOUS DRUGS AND BIOLOGICS (D7)**

**Resolution No. 171-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Drugs and Biologics under Livestock Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of ₱1,050,747.00 and grouped into two (2) lots as follows:

Lot 1- Vaccines (Biologics)	₱ 356,400.00
Lot 2- Antibiotics	₱ 694,347.00

WHEREAS, an opening of bids was conducted on April 19, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bids of Pacifica Agrivet Supplies, Inc. and P & J Agricultural Trading, Inc. as "passed" during the preliminary examination of bids;

WHEREAS, said bids were subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on April 26, 2021 and declared the bid of Pacifica Agrivet Supplies, Inc. for Lots 1 and 2 as Lowest Calculated Bid (LCB);

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Pacifica Agrivet Supplies, Inc. had passed the post qualification requirements and considered as Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of Lot1-Vaccines and Lo2-Antibiotics to Pacifica Agrivet Supplies, Inc. as its bid was considered as the Lowest Calculated and Responsive Bid;
