**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT
OF LIVESTOCK FEEDS AND DRUGS (B16)**

Resolution No. 174 - 2021
Series of 2021

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 27, 2021 and posted for the second time on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Livestock Feeds and Drugs (Rebidding) under Livestock Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of ₱1,986,960.00 and grouped into two (2) lots as follows:

Lot 1- Feeds	₱1,795,385.00
Lot 2- Drugs	₱ 191,575.00

WHEREAS, an opening of bids was conducted on April 19, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bids of Pacifica Agrivet Supplies, Inc. and P & J Agricultural Trading, Inc. as "passed" during the preliminary examination of bids;

WHEREAS, said bids were subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on April 26, 2021 and declared the bid of Pacifica Agrivet Supplies, Inc. for Lot 1 as a Single Calculated Bid and P & J Agricultural Trading, Inc. for Lot 2 as the Lowest Calculated Bid (LCB);

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Pacifica Agrivet Supplies, Inc. and P & J Agricultural Trading, Inc. had passed the post qualification requirements and considered as a Single Calculated and Responsive Bid and the Lowest Calculated and Responsive Bid, respectively;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of Lot1-Feeds to Pacifica Agrivet Supplies, Inc. and Lot2-Drugs to P & J Agricultural Trading Inc. as their bid were considered as a Single/Lowest Calculated and Responsive Bid, respectively;
