**BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROCUREMENT OF 3 UNITS  
RECIRCULATING DRYER POWERED BY A GENERATOR SET (B21)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 3 Units Recirculating Dryer powered by a Generator Set under Rice Program-GAA 2021 with an ABC of 6,000,000.00;

WHEREAS, an opening of bids was conducted last March 4, 2021 at the DA Conference Room as scheduled and the BAC had declared bid of Agri Component Corporation as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the result of detailed bid evaluation, the BAC declared the bid submitted by Agri Component Corporation as a Single Calculated Bid and to undergo post qualification;


WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Agri Component Corporation's bid had passed the post qualification requirements and was declared a Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 3 Units Recirculating Dryer powered by a Generator Set to Agri Component Corporation, as its bid was considered a Single Calculated and Responsive Bid.
