**BAC RESOLUTION ON THE PRELIMINARY EXAMINATION OF BIDS FOR THE  
 PROCUREMENT OF VARIOUS MACHINERIES AND EQUIPMENT FOR RICE (B22)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Machineries and Equipment for Rice under the Rice Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of ₱1,566,000.00 and grouped into four (4) lots as follows:

<b>Lot 1- 2 units Hand Tractor (Walking-type Agricultural Tractor (Pull-type)</b>	<b>₱260,000.00</b>
<b>Lot 2- 2 units Floating Tiller (Mudboat)</b>	<b>₱220,000.00</b>
<b>Lot 3- 2 units Transplanter (WalkBehind Type)</b>	<b>₱826,000.00</b>
<b>Lot 4- 2 units Rice Thresher</b>	<b>₱260,000.00</b>

WHEREAS, a pre-bid conference was held last February 19, 2021 at DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled;

WHEREAS, an opening of bids was conducted on March 4, 2021, 9:15 A. M. at DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled;

WHEREAS, there were two (2) bidders who bought and submitted its bid, namely Ford Tractor Philippines Inc. and Fortunetract Agro-Sales Inc.;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of each bid to verify the presence or absence of the required documents and were rated as follows:
