**BAC RESOLUTION ON THE DETAILED BID EVALUATION FOR THE
PROCUREMENT OF VARIOUS MACHINERIES AND EQUIPMENT FOR RICE (B22)**

**Resolution No. 190-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 12, 2021 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Machineries and Equipment for Rice under the Rice Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of ₱1,566,000.00 and grouped into four (4) lots as follows:

Lot 1- 2 units Hand Tractor (Walking-type Agricultural Tractor (Pull-type)	₱260,000.00
Lot 2- 2 units Floating Tiller (Mudboat)	₱220,000.00
Lot 3- 2 units Transplanter (WalkBehind Type)	₱826,000.00
Lot 4- 2 units Rice Thresher	₱260,000.00

WHEREAS, an opening of bids was conducted on March 4, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and there were two (2) bidders who bought and submitted its bid, namely Ford Tractor Philippines Inc. and Fortunetract Agro-Sales Inc.;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of each bid and all bidders were rated as "passed";

WHEREAS, the financial component of the above two (2) bids were opened and read as indicated on the abstract of bids which are subject to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Fortunetract Agro-Sales Inc. for Lot 1 is a Single Calculated Bid, while the bid submitted by Ford Tractor Philippines Inc. for Lot 3 is the Lowest Calculated Bid (LCB) and both were qualified to undergo post qualification;

WHEREAS, there were no bids received for Lot2 and Fortunetract Agro-Sales, Inc.'s bid for Lot 4 is declared disqualified due to non-compliance to specifications;
