**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF HYBRID RICE SEEDS (D4)**

**Resolution No. 205-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Hybrid Rice Seeds under Rice Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of P9,500,000.00 and grouped into two (2) lots as follows:

Lot 1- 1,000 bags Hybrid Rice Seeds (Mestizo 28)	P4,500,000.00
Lot 2- 1,000 bags Hybrid Rice Seeds (Mestizo 80)	P5,000,000.00

WHEREAS, an opening of bids was conducted on April 19, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bids of OJM Seed Producer and Agricultural Services and Longping Tropical Rice Development, Inc. as "passed" during the preliminary examination of bids;

WHEREAS, said bids were subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on April 26, 2021 and declared the bids of OJM Seed Producer and Agricultural Services for Lot 1 and Longping Tropical Rice Development, Inc. for Lot 2 as Single Calculated Bids (SCB);

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that of OJM Seed Producer and Agricultural Services for Lot1 and and Longping Tropical Rice Development, Inc. for Lot2 had passed the post qualification requirements and both were considered as a Single Calculated and Responsive Bid ;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of Lot 1- 1,000 bags Hybrid Rice Seeds (Mestizo 28) to OJM Seed Producer and Agricultural Services and Lot 2- 1,000 bags Hybrid Rice Seeds (Mestizo 80) to Longping Tropical Rice Development, Inc. as their bid were both considered as a Single Calculated and Responsive Bid;

RESOLVED, this 6th day of May 2021 at Butuan City, Philippines.


