**BAC RESOLUTION RECOMMENDING THE AWARD FOR THE
PROCUREMENT OF 1,231 BOTTLES INSECTICIDE (ACUTE) (D1)**

**Resolution No. 207-2021-A
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1,231 bottles Insecticide (Acute) under Corn Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of ₱1,169,450.00;

WHEREAS, an opening of bids was conducted on April 19, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bid of Jeels Masagana Farm Supply, Inc. as "passed" during the preliminary examination of bids;

WHEREAS, said bid was subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on April 26, 2021 and was declared as Single Calculated Bid (SCB);

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Jeels Masagana Farm Supply, Inc had passed the post qualification requirements and was considered a Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 1,231 bottles Insecticide (Acute) to Jeels Masagana Farm Supply, Inc as its bid was considered as a Single Calculated and Responsive Bid.
