**BAC RESOLUTION ON THE DETAILED BID EVALUATION FOR THE  
PROCUREMENT OF VARIOUS PLANTING MATERIALS (E2)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last May 22, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Planting Materials under HVCD Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of P1,950,000.00 and grouped into two (2) lots as follows:

Lot 1- 28,500 pcs Banana-Lakatan (in-vitro derived plantlets/tissue cultured)	P1,425,000.00
Lot 2- 15,000 pcs Grafted Cacao (Certified Planting Materials): 10,500 pcs UF18 2,250 pcs BR25 2,250 pcs PBC 123 or K2	P 525,000.00

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/asn-ywbi-ofm> last May 31, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on June 14, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and there were four (4) bidders who bought and submitted its bid, namely PELF Plant Nursery, Tierra Organia Corporation, Binahon Agroforestry Farm and St. Padre Pios Garden;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of each bid and the four (4) bidders were rated as "passed";

WHEREAS, the financial component of the four (4) bids were opened and read as indicated on the abstract of bids which are subject to a detailed bid evaluation;


