**BAC RESOLUTION RECOMMENDING AWARD FOR THE SUPPLY AND DELIVERY
OF 19,243 BAGS UREA (46-0-0) GRANULES E-D2**

**Resolution No. 229-2021

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last May 22, 2021 and posted for the second time on the Bulletin Board of this office continuously for 7 calendar days for the supply and delivery of 19,243 bags Urea (46-0-0) Granules under Rice Program- GAA 2021 with a total Approved Budget for the Contract (ABC) of P22,706,740.00;

WHEREAS, an opening of bids was conducted on June 14, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the lone bid of Modern Time Enterprises, Inc. as "passed" during the preliminary examination of bids;

WHEREAS, said bid was subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on June 21, 2021 and declared the bid of Modern Time Enterprises, Inc. as a Single Calculated Bid and to be subjected to post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Modern Time Enterprises, Inc. had passed the post qualification requirements and considered as a Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 19,243 bags Urea (46-0-0) Granules to Modern Time Enterprises, Inc. as its bid was considered as a Single Calculated and Responsive Bid;
