**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT
OF 300 BAGS HYBRID CORN SEEDS (F4)**

**Resolution No. 270-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last June 3, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 300 bags Hybrid Corn Seeds under Corn Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of P1,500,000.00;

WHEREAS, an opening of bids was conducted on June 23, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and there were two (2) bidders who submitted its bid, namely Jedeco Trading Corp. and Fareast Agricultural Seed MPC, all were rated as "passed";

WHEREAS, said bids were subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on July 1, 2021 and declared the bid of Fareast Agricultural Seed MPC as the Lowest Calculated Bid and to be subjected to post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Fareast Agricultural Seed MPC had passed the post qualification requirements and considered as the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 300 bags Hybrid Corn Seeds to Fareast Agricultural Seed MPC as its bid was considered the Lowest Calculated and Responsive Bid;


