**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF TEN UNITS ONE STEP RT-PCR REAGENTS (G6)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last July 7, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 10 units One Step RT-PCR Reagents under Quick Response Fund-Regulatory with a total Approved Budget for the Contract (ABC) of One Million Seven Hundred Fifty Thousand Pesos (₱1,750,000.00);

WHEREAS, an opening of bids was conducted on July 27, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bid of Medical Test Systems Incorporated as "passed" during the preliminary examination of bids;

WHEREAS, said bid was subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on August 4, 2021 and declared the bid of Medical Test Systems as a Single Calculated Bid and subjected to post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Medical Test Systems had passed the post qualification requirements and considered as a Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of 10 units One Step RT-PCR Reagents to Medical Test Systems as its bid was considered a Single Calculated and Responsive Bid;
