BAC RESOLUTION RECOMMENDING THE AWARD FOR THE PROCUREMENT OF TRUCK MOUNTED LONG DISTANCE/WIDE RANGE SPRAYER THRU NEGOTIATED PROCUREMENT-TWO FAILED BIDDINGS

Resolution No. 252-2021
Series of 2021

WHEREAS, the Department of Agriculture Regional- Caraga needs to procure 1-unit Truck Mounted Long Distance/ Wide Range Sprayer with an ABC of Three Million Seven Hundred Thousand Pesos (P 3,700,000.00) under the Rice Program -GAA 2021;

WHEREAS, there had been two failures of competitive biddings declared by the BAC due to no bid received during the opening of bids on August 18, 2020 and the second was due to non-complying bid received last November 25, 2020;

WHEREAS, Sec. 53.1 of the Revised IRR, provides for the Negotiated Procurement in case of **Two Failed Biddings**, where the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier, contractor or consultant where there has been failure of competitive bidding;

WHEREAS, based on abovementioned provisions and considering that time is of the essence arising from the effects of COVID-19 that needs immediate action, the Bids and Awards Committee of this office hereby resort to Alternative Mode of Procurement using Negotiated Procurement-Two Failed Bidding;

WHEREAS, after review of the technical specifications, terms and conditions of the contract, the BAC invited qualified supplier based on legal, technical and financial capability;

WHEREAS, a meeting was held last February 24, 2021 at the DA- Caraga Conference Hall and simultaneously via teleconference with the supplier to discuss the specifications, terms and other conditions of the contract and invited the supplier to submit proposal together with the complete documentary requirements;

WHEREAS, the BAC received one (1) proposal from Brixton Construction & Industrial Supply Corporation which was subsequently reviewed by the BAC-TWG for its compliance with the technical specifications and other documentary requirements;

WHEREAS, upon final deliberation of the detailed evaluation by the BAC on April 22, 2021 found that Brixton Construction & Industrial Supply Corporation has complied with all the documentary requirements as to legal, technical and financial;

WHEREAS, after conduct of series of activities to negotiate said project, the BAC was informed by the BAC Secretariat that the said project was inadvertently not published as required, that made the award void, hence, it was cancelled;

WHEREAS, on August 7, 2021 a Request for Quotation was posted in the websites of PhilGEPS and DA-Caraga as well as on the BAC Bulletin and invited 3 suppliers to join the scheduled Negotiated Conference to discuss the technical requirements of 1-unit Truck Mounted Long Distance/Wide Range Sprayer;

WHEREAS, a meeting was held last August 11, 2021 at the DA- Caraga Conference Hall and simultaneously via teleconference with the supplier to discuss the specifications, terms and other conditions of the contract and invited the supplier to submit proposal together with the complete documentary requirements;

WHEREAS, the BAC received only one (1) proposal from Brixton Construction & Industrial Supply Corporation which was subsequently reviewed by the BAC-TWG for its compliance with the technical specifications and other documentary requirements;

WHEREAS, upon deliberation of the detailed evaluation by the BAC on August 31, 2021 found that Brixton Construction & Industrial Supply Corporation has complied with all the documentary requirements as to legal, technical and financial requirements;

WHEREAS, the BAC conducted post qualification to Brixton Construction & Industrial Supply Corporation on September 3 and 6, 2021 to ensure its performance of the contract if awarded;

WHEREAS, the BAC and the TWG conducted the final deliberation on September 13, 2021 and found that Brixton Construction & Industrial Supply Corporation is compliant with all the requirements of the project;

WHEREAS, the BAC Secretariat found out that the publication in the PhilGEPS website has an error on the ABC which indicated only P1,700,000 instead of P3,700,000, and it was republished on September 10, 2021, hence the BAC suspends its decision to award pending the result of the republication;

WHEREAS, on September 16, 2021, the BAC convened and found out that after the closing date of the publication, there was no intents nor bids received, hence, the BAC considered the bid submitted by Brixton Construction & Industrial Supply Corporation as it was the only bid received and has complied with all the requirements;

NOW THEREFORE, to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the procurement of 1-unit Truck Mounted Long Distance/ Wide Range Sprayer to Brixton Construction & Industrial Supply Corporation, as its offer is considered a Single Calculated and Responsive Bid.
