**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF HYBRID CORN SEEDS
 GM YELLOW (H3)**

Resolution No. 2021-2081

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last August 20, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Hybrid Corn Seeds GM Yellow under Corn Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of Three Million Three Hundred Thousand Pesos (P3,300,000.00) and grouped into five (5) lots as follows:

Lot 1- 100 bags Hybrid Corn Seeds (NSIC GMCn 57)	P 600,000.00
Lot 2- 150 bags Hybrid Corn Seeds (NSIC GMCn 54)	P 900,000.00
Lot 3- 100 bags Hybrid Corn Seeds (NSIC GMCn 67)	P 600,000.00
Lot 4- 100 bags Hybrid Corn Seeds (NSIC GMCn 48)	P 600,000.00
Lot 5- 100 bags Hybrid Corn Seeds (NSIC GMCn 44)	P 600,000.00

WHEREAS, an opening of bids was conducted on September 13, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and there were three (3) bidders who bought and submitted its bid, namely Jedeco Trading Corporation, Asian Hybrid Seed Technologies, Inc. and Rightagri Dev. Inc., all rated as "passed";

WHEREAS, said bids were subjected to a detailed bid evaluation by the Technical Working Group and accordingly, result was deliberated by the BAC on September 20, 2021 and declared the bids submitted by Jedeco Trading Corporation for Lots 3, 4 and 5 as a Single Calculated Bid, Asian Hybrid Seed Technologies, Inc. for Lot 1 also as a Single Calculated Bid and Rightagri Dev. Inc. for Lot 2 as a Single Calculated Bid, and all were subjected for post qualification;

WHEREAS, the BAC and the TWG conducted the post qualification to determine the authenticity of the submitted documents and to determine its capacity to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was found out that Jedeco Trading Corporation, Asian Hybrid Seed Technologies, Inc., and Rightagri Dev. Inc. had passed the post qualification requirements and considered all as Single Calculated and Responsive Bids;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Abel James I. Monteagudo to award the supply and delivery of Lot 1 to Asian Hybrid Seed Technologies, Inc.; Lot 2 to Rightagri Dev. Inc. and Lots 3, 4 and 5 to Jedeco Trading Corporation as their bids were considered Single Calculated and Responsive Bids;


