WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last October 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Agricultural Supplies under BP2 Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of **One Million Seven Hundred Twelve Thousand Five Hundred Pesos (P1,712,500.00)** and grouped into two (2) lots as follows:

<b>Lot 1- 200 pcs. Knapsack Sprayer</b>	<b>P 885,000.00</b>
<b>Lot 2- 200 pcs. Plastic Drum 450 pcs. Steel Drum</b>	<b>P 827,500.00</b>

WHEREAS, an opening of bids was conducted on November 17, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and can be participated virtually through <https://meet.google.com/jfm-ekny-uqe>;

WHEREAS, there were four (4) bidders who bought and submitted its bid, namely DJ & J Trading and General Merchandise, J-777 Agri Marketing Corp., Basic Agri Industrial Sales and RMB Agro Chemicals Trading Corporation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Basic Agri Industrial Sales for Lot 1 is the Lowest Calculated Bid and the bid submitted by J-777 Agri Marketing Corp. for Lot 2 as a Single Calculated Bid, both subject for post qualification;

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last October 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Agricultural Supplies under BP2 Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of **One Million Seven Hundred Twelve Thousand Five Hundred Pesos (P1,712,500.00)** and grouped into two (2) lots as follows:

<b>Lot 1- 200 pcs. Knapsack Sprayer</b>	<b>P 885,000.00</b>
<b>Lot 2- 200 pcs. Plastic Drum 450 pcs. Steel Drum</b>	<b>P 827,500.00</b>

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/myo-zwvt-fux> last November 4, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on November 17, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bids of DJ & J Trading and General Merchandise, J-777 Agri Marketing Corp., Basic Agri Industrial Sales and RMB Agro Chemicals Trading Corporation as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on November 24, 2021, the BAC declared the bids submitted by Basic Agri Industrial Sales for Lot 1 as the Lowest Calculated Bid and J-777 Agri Marketing Corp. for Lot 2 as Single Calculated Bid, both were qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on November 26, 2021 the post qualification to Basic Agri Industrial Sales and J-777 Agri Marketing Corp. being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on December 6, 2021, it was found out that Basic Agri Industrial Sales and J-777 Agri Marketing Corp. had passed the post qualification requirements and were considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of Various Agricultural Supplies to Basic Agri Industrial Sales for Lot 1 and J-777 Agri Marketing Corp. for Lot 2 as its bid was considered the Lowest Calculated and Responsive Bid.
