**BAC RESOLUTION RECOMMENDING AWARD FOR THE
LABOR AND MATERIALS FOR THE CONSTRUCTION OF COFFEE PROCESSING FACILITY (I9)**

**Resolution No. 715-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last October 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Labor and Materials for the Construction of Coffee Processing Facility under High Value Crops Development Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of **One Million Nine Hundred Eighty Thousand Pesos (P1,980,000.00)**;

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/myo-zwvt-fux> last November 4, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on November 17, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC declared the bids of Jimberns Builders & Construction Supply and BN Builders & Construction Supplies as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on November 24, 2021, the BAC determined that the bid submitted by Jimberns Builders & Construction Supply is the Lowest Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on November 26, 2021 the post qualification to Jimberns Builders & Construction Supply being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on December 15, 2021, it was found out that Jimberns Builders & Construction Supply did not pass the post qualification requirements due to unfinished projects with DA Caraga;

WHEREAS, BN Builders & Construction Supplies having the next lowest bid was considered and found to have passed the post qualification requirements;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of Labor and Materials for the Construction of Coffee Processing Facility to BN Builders & Construction Supplies as its bid was considered the Lowest Calculated and Responsive Bid.


