**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF ICT EQUIPMENT (I1)**

**Resolution No. 320-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last October 27, 2021 and posted for the second time on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of ICT Equipment (Rebidding) under RSBSA-GAA 2021 with a total Approved Budget for the Contract (ABC) of **One Million Six Hundred Ninety Thousand Pesos (P1,690,000.00)** and grouped into two (2) lots as follows:

Lot 1- 22 units Desktop Computer	P 880,000.00
Lot 2- 18 units Laptop Computer	P 810,000.00

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/myo-zwvt-fux> last November 4, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on November 17, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bid of Solidmark, Inc. for Lot 1 as "passed" during the preliminary examination of bids;

WHEREAS, no bids were received for Lot 2, hence the BAC declared a Failed Bid pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184).

WHEREAS, upon deliberation on the detailed bid evaluation conducted on November 24, 2021, the BAC declared the bid submitted by Solidmark, Inc. for Lot 1 as a Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on November 26, 2021 the post qualification to Solidmark, Inc. being a Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on December 6, 2021, it was found out that Solidmark, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of Twenty-two (22) units Desktop Computer to Solidmark, Inc. as its bid was considered the Lowest Calculated and Responsive Bid.


