**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF 210 BAGS HYBRID CORN SEEDS WHITE (I2/H2)**

**Resolution No. 724-2021
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last October 27, 2021 and posted for the second time on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 210 bags Hybrid Corn Seeds (White) (Rebidding) under Corn Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of **One Million One Hundred Fifty Five Thousand Pesos (P1,155,000.00)**;

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/myo-zwvt-fux> last November 4, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on November 17, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bid of Fareast Agricultural Seeds MPC as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation on the detailed bid evaluation conducted on November 24, 2021, the BAC declared the bid submitted by Fareast Agricultural Seeds MPC as a Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on November 26, 2021 the post qualification to Fareast Agricultural Seeds MPC being a Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on December 6, 2021, it was found out that Fareast Agricultural Seeds MPC had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of 210 bags Hybrid Corn Seeds (White) to Fareast Agricultural Seeds MPC as its bid was considered the Lowest Calculated and Responsive Bid.


