**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF POULTRY ANIMALS
(J7/119)**

Resolution No. 329 - 2021

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Poultry Animals under Balik Probinsya 2- GAA 2021 with a total Approved Budget for the Contract (ABC) of **Four Million Five Hundred Fifty Eight Thousand Nine Hundred Twenty Five Pesos (P4,558,925.00) grouped into two (2) lots;**

Lot 1 - 1,889 heads Chicken (RTL) and 566 heads Free Range Chicken - P 1,558,925.00
Lot 2 - 5,000 Heads Ducks - P 3,000,000.00

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/veu-diza-sra> last December 6, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on December 20, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and can be participated virtually through <https://meet.google.com/wpj-rywk-azc>;

WHEREAS, there was only one (1) bidder who bought and submitted its bid, namely, Juniel's Farm and Agrivet Supply;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical and financial component of its bid to verify the presence or absence of the required documents and was rated as "passed" and subsequently subjected to post qualification:

WHEREAS, the BAC together with the TWG conducted on December 23, 2021 the post qualification to Juniel's Farm and Agrivet Supply, having the Single Calculated Bid on Lot 1 and Lot 2 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on December 24, 2021, it was declared that Juniel's Farm and Agrivet Supply had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid both for Lot 1 and Lot 2;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of Poultry Animals Lot 1 and Lot 2 to Juniel's Farm and Agrivet Supply as its bid was considered the Single Calculated and Responsive Bid;
