BAC RESOLUTION ON THE PRELIMINARY EXAMINATION OF BIDS FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF MUSHROOM HOUSE (J2/I21)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of Mushroom House under the Balik Probinsya 2- GAA 2021 with a total Approved Budget for the Contract (ABC) of **Two Million Nine Hundred Sixty Thousand Pesos (₱2,960,000.00)**, grouped into two (2) lots;

Lot 1 - (13 units Brgy. Labnig, Talacogon, ADS; 2 units Brgy. Buena Gracia, Talacogon, ADS; 82 units Zillovia, Talacogon, ADS; 1 unit Magsaysay, Jabonga, A D N) - P1,960,000.00

Lot 2 - (11 units Bunga, Lanuza, SDS; 11 units Agsam, Lanuza, SDS; 28 units Sibahay Lanuza, SDS) - P1,000,000.00

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/veu-diza-sra> last, December 6, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on December 20, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and can be participated virtually through <https://meet.google.com/wpj-rywk-azc>;

WHEREAS, there were two (2) bidders who bought and submitted bid, namely, NESLI CONSTRUCTION and NAHARO BUILDERS INC;


WHEREFORE, the financial component was opened and read as indicated on the abstract of bids which were subject to a detailed bid evaluation;

WHEREAS, no bids were received for Lot 2, hence the BAC declared a Failed Bid pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184).

NOW THEREFORE, the BAC recommends to the Head of Procuring Entity, Regional Executive Director Ricardo M. Oñate, Jr., to declare failure of bidding for the second time for Lot 2 *composed of 11 units at Bunga, Lanuza, SDS; 11 units at Agsam, Lanuza, SDS; 28 units at Sibahay Lanuza, SDS* and to resort to Negotiated Procurement-Two Failed Biddings to fast tract its procurement
