



**BAC RESOLUTION RECOMMENDING AWARD FOR THE  
PROCUREMENT OF FEEDS AND VITAMINS (J5/116)**

**Resolution No. 364-2021  
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Feeds and Vitamins under Balik Probinsya 2- GAA 2021 with a total Approved Budget for the Contract (ABC) of **Two Million Four Hundred Fifty-Six Thousand Seven Hundred Thirty-Six Pesos (P2,456,736.00)**:

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/veu-diza-sra> last, December 6, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on December 20, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bidder who bought and submitted its bid, namely, Hiron's Merchandise;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of its bid to verify the presence or absence of the required documents and subsequently was rated as "passed" and was subjected to post qualification:

WHEREAS, the BAC together with the TWG conducted on December 23, 2021 the post qualification to Hiron's Merchandise. having the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on December 24, 2021, it was found out that Hiron's Merchandise had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of Feeds and Vitamins to Hiron's Merchandise as its bid was considered the Single Calculated and Responsive Bid;
