**BAC RESOLUTION RECOMMENDING THE AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF MUSHROOM HOUSE THRU NEGOTIATED PROCUREMENT-TWO FAILED BIDDINGS**

WHEREAS, the Department of Agriculture Regional- Caraga intends to procure labor and materials for the construction of Mushroom House with an ABC of One Million Pesos (P 1,000,000.00) under the Balik Probinsya 2 Program to provide livelihood and enterprise development support to principal and local balik probinsya beneficiaries;

WHEREAS, there had been two failed biddings declared by the BAC due to no bids received during the opening of bids on November 17, 2021 and on December 20, 2021;

WHEREAS, Sec. 53.1 of the Revised IRR, provides for the Negotiated Procurement in case of Two Failed Biddings, where the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier, contractor or consultant where there has been failure of competitive bidding;

WHEREAS, based on abovementioned guidelines and considering that time is of the essence arising from the effects of COVID-19 that needs immediate action, the Bids and Awards Committee of this office hereby resort to Alternative Mode of Procurement using Negotiated Procurement-Two Failed Bidding;

WHEREAS, after review of the technical specifications, terms and conditions of the contract, the BAC invited qualified supplier based on legal, technical and financial capability based on records;

WHEREAS, a meeting was held last December 23, 2021 at the DA- Caraga Conference Hall and simultaneously via teleconference through meeting link: <https://meet.google.com/onq-mhcs-ckh>, for the supplier who was not able to come physically, to discuss the specifications and other technical requirements of the projects and invited them to submit proposals the soonest possible time;

WHEREAS, the BAC received only one (1) RFQ/proposal from the invited suppliers, namely; Mack's Construction which was subsequently reviewed by the BAC-TWG for its compliance to the specifications and other documentary requirements;

WHEREAS, the BAC in its deliberation on December 29, 2021 found that Mack's Construction bid was compliant to the technical requirements, hence, declared as a single calculated and responsive bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Engr. Ricardo M. Oñate, Jr. to award the provision of labor and materials for the Construction of Mushroom House to Mack's Construction, as its bid/offer is considered the Single Calculated and Responsive Bid.
