**BAC RESOLUTION RECOMMENDING AWARD FOR THE  
PROCUREMENT OF VARIOUS AGRICULTURAL EQUIPMENT (I12)**

**Resolution No. 725-2021  
Series of 2021**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last October 27, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Agricultural Equipment under High Value Crops Development Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of **Four Million One Hundred Eighty Thousand Pesos (P4,180,000.00)** and grouped into six (6) lots as follows:

<b>Lot 1- 33 units Grass Cutter</b>	<b>P 825,000.00</b>
<b>Lot 2- 27 units Chainsaw</b>	<b>P 945,000.00</b>
<b>Lot 3- 25 units Soil Auger</b>	<b>P 750,000.00</b>
<b>Lot 4- 3 units Shredder</b>	<b>P 735,000.00</b>
<b>Lot 5- 2 units Composting Machine</b>	<b>P 400,000.00</b>
<b>Lot 6- 13 units Power Sprayer (engine driven) 2 units Power Sprayer (electric driven)</b>	<b>P 525,000.00</b>

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/myo-zwvt-fux> last November 4, 2021 as scheduled;

WHEREAS, an opening of bids was conducted on November 17, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC had declared the bids of Basic Agri Industrial Sales, RMB Agro Chemicals Trading Corporation, J-777 Agri Marketing Corp., Diamond Star Industrial Trading, Universal Commercial Corporation and DP Fabrication and Machineries as "passed" and the bids of DJ & J Trading and General Merchandise and GTR Marketing as "failed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on November 24, 2021, the BAC declared the bids submitted by Universal Commercial Corporation for Lots 1, 2 and 4, Basic Agri Industrial Sales for Lot 3 and DP Fabrication and Machineries for Lot 6 as the Lowest Calculated Bid, all were qualified to undergo post qualification;

WHEREAS, no bids were received for Lot 5, hence the BAC declared a Failed Bid pursuant to Section 35.1(a) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184).

WHEREAS, the BAC together with the TWG conducted on November 26, 2021 the post qualification to Universal Commercial Corporation, Basic Agri Industrial Sales and DP Fabrication and Machineries being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on December 6, 2021, it was found out that Universal Commercial Corporation, Basic Agri Industrial Sales and DP Fabrication and Machineries had passed the post qualification requirements and were considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of Various Agricultural Equipment to Universal Commercial Corporation for Lots 1, 2 and 4, Basic Agri Industrial Sales for Lot 3 and DP Fabrication and Machineries for Lot 6 as its bid was considered the Lowest Calculated and Responsive Bid.
