**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF
2 UNITS CORN PLANTER (B4/A16)**

**Resolution No. 686-2022
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 11, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of two (2) units Corn Planter under Corn Program with a total Approved Budget for the Contract (ABC) of **Three Million Four Hundred Thousand Pesos (P3,400,000.00)**.

WHEREAS, an opening of bids was conducted on March 7, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and the BAC declared the lone bid of All Certified Equipment Trading Corporation as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on March 11, 2022, the BAC determined that the bid submitted by All Certified Equipment Trading Corporation as the Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on March 15, 2022, a virtual post qualification, via meet.google.com/bdd-ewqv-yak, to All Certified Equipment Trading Corporation being the Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on March 18, 2022, it was found out that All Certified Equipment Trading Corporation had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;



RESOLVED, this 18th day of March 2022 at Butuan City, Philippines.


