**BAC RESOLUTION RECOMMENDING AWARD THE PROCUREMENT OF SENTINEL ANIMAL SWINE (C1/A3) THRU NEGOTIATED PROCUREMENT DUE TO 2-FAILED BIDS**

**Resolution No. 217-2022  
Series of 2022**

WHEREAS, the Department of Agriculture Regional- Caraga intends to procure 180 heads Sentinel Animal Swine under the Livestock Program - GAA 2022 with a total Approved Budget for the Contract (ABC) of **One Million Four Hundred Forty Thousand Pesos (P1,440,000.00)** grouped into 4 lots:

- Lot 1 - (54 heads) Sentinel Animal Swine for Agusan del Sur (Talacogon and Prosperidad) Php432,000.00
- Lot 2 - (81 heads) Sentinel Animal Swine for Agusan del Sur (San Francisco and Veruela) Php648,000.00
- Lot 3 - (15 heads) Sentinel Animal Swine for Agusan del Norte (Butuan City, Buenavista & Las Nieves) Php120,000.00
- Lot 4 - (30 heads) Sentinel Animal Swine for Surigao del Sur and Surigao del Norte (Bayabas, SDS & Claver, SDN) Php240,000.00

WHEREAS, there had been two failed biddings declared by the BAC due to no bids received during the opening of bids scheduled on November 29, 2021 and on April 19, 2022;

WHEREAS, Sec. 53.1 of the Revised IRR, provides for the Negotiated Procurement in case of **Two Failed Biddings**, where the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier, contractor or consultant where there has been failure of competitive bidding;

WHEREAS, based on above mentioned guidelines, the Bids and Awards Committee of this office hereby resort to Alternative Mode of Procurement using Negotiated Procurement-Two Failed Bidding;

WHEREAS, after review of the technical specifications, terms and conditions of the contract, the BAC posted an Invitation to a negotiated procurement at the PhilGeps and Agency websites and invited qualified suppliers who has the legal, technical and financial capability based on records of the agency;

WHEREAS, a meeting was held last April 28, 2022 via teleconference to discuss the specifications and other technical requirements of the projects and invited them to submit proposals within the deadline;

WHEREAS, the BAC received three (3) proposals from the invited/interested suppliers, namely; Juniel's Farm & Agrivet Supply, MSC Center for the Poor, Inc. and NJ Agrivet and Garden Supply which were subsequently reviewed by the BAC-TWG for its compliance to the specifications and other documentary requirements;


WHEREAS, the BAC in its deliberation on May 20, 2022 found that MSC Center for the Poor, Inc. has the lowest calculated bid and found to be compliant to the technical requirements upon post qualification, hence, declared as the lowest calculated and responsive bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Engr. Ricardo M. Oñate, Jr. to award the supply and delivery of 180 heads Sentinel Animal Swine under Lots 1-4 to MSC Center for the Poor, Inc., as its bid/offer is considered the Lowest Calculated and Responsive Bid.
