**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF  
1 UNIT RICE COMBINE HARVESTER (C9)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 25, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the procurement of 1-unit Rice Combine Harvester under Rice Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **One Million Eight Hundred Thousand Pesos (P 1,800,000.00)**;

WHEREAS, an opening of bids was conducted on April 19, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and the BAC declared the bids of Fortunetract Agro Sales Inc. and Agri Component Corporation as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Fortunetract Agro Sales Inc. as disqualified due to unmet specification specifically on the Threshed Grain Output Capacity based on AMTEC Test Report as verified by the BAC-TWG;

WHEREFORE, the BAC considered the next lowest bid of Agri Component Corporation and it was found to be compliant to the specifications, hence, declared the bid to be the Lowest Calculated Bid to be subjected to a post qualification;

WHEREAS, the BAC together with the TWG conducted a post qualification to Agri Component Corporation being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon further deliberation conducted by the BAC members on June 13, 2022, it was found out that Agri Component Corporation had passed the post qualification requirements and was eligible for award;

WHEREAS, the BAC conducted the final deliberation on June 27, 2022 and declared the bid of Agri Component Corporation as the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of 1-unit Rice Combine Harvester to Agri Component Corporation as its bid was considered the Lowest Calculated and Responsive Bid;
