RESOLUTION RECOMMENDING THE PROCUREMENT OF 471 BOTTLE OF INSECTICIDE AND 471 GALLON OF HERBICIDE THRU NEGOTIATED PROCUREMENT-EMERGENCY PURCHASES

WHEREAS, the Department of Agriculture-Regional Office Caraga intends to procure 471 Liter of Insecticide and 471 Gallon Herbicide through Corn Program with an ABC of **One Million Four Hundred Thirty Six Thousand Five Hundred Fifty Pesos (P 1,436,550.00)** under the Quick Response Fund (QRF 2nd Tranche);

WHEREAS, the said production inputs are aimed to help the farmers to recover from the devastated effects of Typhoon Odette and enable them to rehabilitate their farms as soon as possible;

WHEREAS, there is a need to procure these inputs the soonest time possible to provide immediate response to the affected farmers for them to replant and regain their farm losses;

WHEREAS, Section 53.2 of the latest Implementing Rules and Regulations of RA 9184 provides for the Negotiated Procurement-Emergency Cases maybe resorted to in cases of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary;

WHEREAS, the DA issued a memorandum to expedite the procurement of various goods as immediate response to the farmers affected by Typhoon Odette and help them recover from their present state;

WHEREAS, the BAC conducted the procurement activities using the Negotiated Procurement-Emergency Cases to fast tract the procurement process;

WHEREAS, the BAC determined the suppliers who are legally, technically, and financially capable based on records and conducted a meeting to inform the invited bidders on the terms and conditions of this office;

WHEREAS, there were four (4) bidders that submitted its quotation, namely, Jeel's Masagana Farm Supply, Jedeco Trading Corp., Bacphil Planters Fertilizer and Enviro Scope Synergy, Inc. per Abstract of Quotations;

WHEREAS, during the preliminary deliberation by the BAC, it was determined that the bid of Jeel's Masagana Farm Supply was declared the lowest calculated bid and was subjected to post qualification;

WHEREAS, upon final deliberation conducted by the BAC members on June 29, 2022, it was found out that Jeel's Masagana Farm Supply had passed the post qualification requirements and was considered responsive to the required specifications, terms and conditions;


