



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS PLANTING MATERIALS (H1)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 22, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for Procurement of Various Planting Materials under the Coconut Farmers Industry Development Plan (CFIDP) grouped into two (2) lots with corresponding ABC;

Lot 1 – 35,000 pieces Grafted Cacao	1,715,000.00
Lot 2 – 15,000 pieces Coffee (Robusta)	735,000.00

WHEREAS, an opening of bids was conducted on December 12, 2022, 9:15 A. M. at the DA conference hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bid received that was rated as passed, namely, St Padre Pios Garden and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 13, 2022, the BAC determined that the bid submitted by St Padre Pios Garden as a Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on December 15, 2022 the post qualification to St Padre Pios Garden, having been declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, based on the post qualification report, the BAC conducted the final deliberation on the same day and found St Padre Pios Garden qualified and passed the post qualification requirements hence, considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Various Planting Materials, Lot 1- Grafted Cacao, 35,000 pieces and Lot-2 15,000 pcs Coffee to St Padre Pios Garden as its bid was considered the Single Calculated and Responsive Bid;
