**BAC RESOLUTION RECOMMENDING AWARD FOR THE LABOR AND MATERIALS FOR THE CONSTRUCTION OF TWO (2) UNITS GOAT HOUSE- (A6)**

**Resolution No. 004-2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the labor and materials for the Construction of Two (2) Units Goat House – Short of Award under the 4Ks Program-NEP 2022 with a total Approved Budget for the Contract (ABC) of **One Million Fifty Thousand Pesos (₱1,050,000.00)**;

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled on a blended mode through the link: [meet.google.com/myv-ameh-caz](https://meet.google.com/myv-ameh-caz) and the BAC declared the lone bid of BN Builders and Construction Supplies as “passed” during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bid submitted by BN Builders and Construction Supplies is the Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 12, 2022, an onsite post qualification to BN Builders and Construction Supplies being the Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that BN Builders and Construction Supplies had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the labor and materials for the construction of two (2) units Goat House to BN Builders and Construction Supplies as its bid was considered the Single Calculated and Responsive Bid.




