**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF VARIOUS FERTILIZERS- SHORT OF AWARD (A8)**

**Resolution No. 006-1222
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Fertilizers - Short of Award under the Corn Program-NEP 2022 with a total Approved Budget for the Contract (ABC) of **Nine Million Eight Hundred Thirty-Six Thousand Pesos (P9,836,000.00)**, grouped into four (2) lots as follows;

Lot 1 - Inorganic Fertilizer -	6,116,500.00
Lot 2 - Organic Fertilizer -	3,719,500.00

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled thru blended mode using the link: meet.google.com/myv-ameh-caz and the BAC declared the lone bid of Roy Agribest Philippines Inc. as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bid submitted by Roy Agribest Philippines Inc. for Lot 2, as a Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 11, 2022, a virtual post qualification to Roy Agribest Philippines Inc. being the Single Calculated Bid for Lot 2 to determine the authenticity of the submitted documents and its capability to supply the contract;


WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that Roy Agribest Philippines Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;



RESOLVED, this 17th day of January 2022 at Butuan City, Philippines.


