**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF 907 BAGS OPV CORN SEEDS (A9)**

**Resolution No. 007-2022
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 907 bags OPV CornSeeds – Short of Award under the Corn Program-NEP 2022 with a total Approved Budget for the Contract (ABC) of **One Million Six Hundred Thirty-Two Thousand Six Hundred Pesos (P1,632,600.00)**;

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled thru blended mode using the link: meet.google.com/myv-ameh-caz and the BAC declared the bids of CJP Enterprises, Promland Corn Seeds and Fareast Agricultural Seeds MPCas “passed” during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bid submitted by CJP Enterprises as the Lowest Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 13, 2022, anonsite post qualification to CJP Enterprises being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that CJP Enterprises had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of 907 bags OPV Corn Seeds to CJP Enterprises as its bid was considered the Lowest Calculated and Responsive Bid.
