**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF 772 BAGS CONVENTIONAL HYBRID YELLOW CORN SEEDS--(A11)**

**Resolution No. 008-2022

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 772 bags Conventional Hybrid Yellow Corn Seeds - Short of Award under the Corn Program-NEP 2022 with a total Approved Budget for the Contract (ABC) of **Four Million Six Hundred Thirty-Two Thousand Pesos (P4,632,000.00)**;

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled thru blended mode using the link: meet.google.com/myv-ameh-caz and the BAC declared the bids of Promland Corn Seeds and Jedeco Trading Corporation as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bid submitted by Jedeco Trading Corporation as the Lowest Calculated Bid and qualified to undergo post qualification;


WHEREAS, the BAC together with the TWG conducted on January 11, 2022, a virtual post qualification to Jedeco Trading Corporation being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;


WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that Jedeco Trading Corporation had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of 772 bags Conventional Hybrid Yellow Corn Seeds to Jedeco Trading Corporation as its bid was considered the Lowest Calculated and Responsive Bid.


