**BAC RESOLUTION RECOMMENDING AWARD FOR THE  
PROCUREMENT OF VARIOUS FEEDS FOR LIVESTOCK AND POULTRY – (A24)**

**Resolution No. 016-2022  
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the procurement of Various Feeds for Livestock and Poultry – Short of Award under the SAAD-NEP 2022 with a total Approved Budget for the Contract (ABC) of **Seven Million Six Hundred Twenty-Four Thousand Five Hundred Fifteen Pesos (₱1,987,400.00)**;

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC declared the lone bid of Hiron's General Merchandise as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bid submitted by Hiron's General Merchandise as the Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 11, 2022, a virtual post qualification to Hiron's General Merchandise being the Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;


WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that Hiron's General Merchandise had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of various Feeds for Livestock and Poultry to Hiron's General Merchandise as its bid was considered the Single Calculated and Responsive Bid.


