**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT
OF VARIOUS VEGETABLE SEEDS – (A23)**

**Resolution No. 018-2022
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the procurement of Various Vegetable Seeds – Short of Award under the HVCDP-NEP 2022 with a total Approved Budget for the Contract (ABC) of **Seven Million Six Hundred Twenty-Four Thousand Five Hundred Fifteen Pesos (₱ 7,624,515.00)** and grouped into two (2) lots as follows;

Lot 1 – Lowland Vegetable Seeds	4,290,915.00
Lot 2 – Assorted Vegetable Seeds (Buffer Stocks)	3,333,600.00

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC declared the bids of RMB Agro Chemicals Corporation, JeelsMasagana Farm Supply, Allied Botanical Corporation, Green and Grow Teknologies Inc., Ramgo International Corporation and OJM Seed Producer and Agricultural Services as “passed” during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bids submitted by JeelsMasagana Farm Supply as the Lowest Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 10, 2022, an onsite post qualification to Jeels Masagana Farm Supply being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;


WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that Jeels Masagana Farm Supply had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of Various Vegetable Seeds to Jeels Masagana Farm Supply as its bid was considered the Lowest Calculated and Responsive Bid.






