**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF TWO (2) UNITS RICE COMBINE HARVESTER – (A35)**

**Resolution No. D15-2022
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Two (2) Units Rice Combine Harvester – Short of Award under the Rice Program -NEP 2022 with a total Approved Budget for the Contract (ABC) of **Three Million Six Hundred Thousand Pesos (P3,600,000.00)**;

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC declared the bids of Agri Component Corporation, Ford Tractor Philippines, Inc., and Fortunetract Agro-Sales, Inc. as “passed” during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bids submitted by Fortunetract Agro-Sales, Inc. as the Lowest Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 14, 2022, an onsite post qualification to Fortunetract Agro-Sales, Inc. being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that Fortunetract Agro-Sales, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of two (2) Units Rice Combine Harvester to Fortunetrac Agro-Sales, Inc. as its bid was considered the Lowest Calculated and Responsive Bid.


